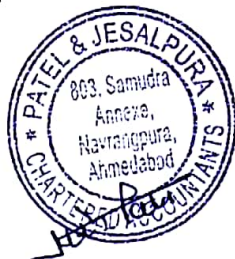

Independent Auditor's Limited Review Report

To

1.
